Scholarship Program Guidelines

The St. Louis CCIM Chapter is excited to offer **Ten (10) partial Scholarships** to be used toward any virtual 2020 CI -103 course.

Ten (10) CCIM partial Scholarships are available to both chapter members and non-member commercial industry practitioners interested in becoming a CCIM Candidate. These scholarships honor individuals for their outstanding leadership and service to their CCIM Chapter, the commercial real estate industry, and their communities.

All scholarships must be used toward the virtual CI-103 classes in 2020.

CI-103 will be held virtually on the following dates:

June 8th - 17th
June 22nd - July 22nd
July 20th - July 29th

August 17th - August 26th
August 24th - September 28th

Applicants need only to submit one (1) application to be eligible for any of the ten (10) scholarships. Only one (1) scholarship per person will be awarded.

- Each applicant should be able to demonstrate active involvement or a future commitment as a Dues paying member of the St. Louis local CCIM Chapter (**See: Application attached**).

Scholarship Value:

Ten (10) recipients will receive one (1) each, \$200 scholarship for tuition reimbursement for a virtual CI-103 class course held in 2020

*Note: Each recipient is responsible for paying their Class Tuition in full, on-line at: www.ccim.com . All payments are to made to National CCIM. Once the scholarship recipient has successfully completed the class course and passed the required testing, the St. Louis CCIM Chapter will reimburse the awardee with the appropriate awarded dollar amount for each scholarship. Reimbursement will typically be in December.

**Note: Failing the course and testing renders the scholarship null and void.

The scholarship cannot be applied retroactively to any course already taken. The award is not redeemable for cash. The Chapter will not reimburse individuals for any courses already taken. Failing the course renders the scholarship null and void.
